- Adhere to the requirement that no person uses the facilities of the Club alone, and in particular there must be at least two (2) people (one of whom undertakes a supervising role at all times) in the gymnasium whenever that facility or equipment is being used.

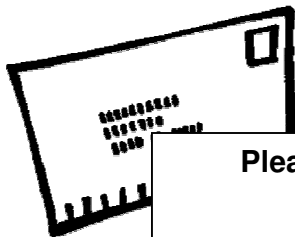
PLEASE NOTE:

- "Non-competitive" means exclusion from competing at Rowing Tasmania Pennant Regattas and events hosted by Tasmanian rowing clubs.
- Competitive members will have preference over equipment use.
- Payment is due and payable in full by the 30th September each year and forwarded with this application form to the address below.
- Fees cover membership of the Lindisfarne Rowing Club, (see membership table) registration with the Rowing Tasmania and entry fees to all pennant regattas. This does not apply to masters rowers.
- The above fees do not cover entry fees at National regattas, Club or School regattas, or any associated costs (such as towing or transport costs for such events), using Club equipment at such regattas, or costs associated with participation at group training camps (e.g. Tamar Regatta is not covered by above fees).
- Members who damage club equipment are liable for a minimum fee of \$25. Heavier penalties will apply for damage resulting from improper behaviour.
- Correct email details are vital for club communication - please sure your email address is clear, legible and correct.
